VISITS BEGIN IN THE FIRST OR SECOND TRIMESTER OF PREGNANCY AND CONTINUE UNTIL THE BABY IS 2 YEARS OLD. NFP IS LIMITED TO 120 LOW-INCOME FAMILIES WHO ARE EXPECTING THEIR FIRST BABY. IT IS PRIMARILY FUNDED BY THE STATE OF COLORADO. 100% OF THE MOTHERS ARE LOW-INCOME.
